## **Responsibilities:**

- Collect, analyze and integrate patient information in order to identify and meet the patientspecific needs (physical/mental limitations, current emotional/physiological status regarding the testing procedure, pertinent medical/social history).
- Determine final testing parameters/procedures in conjunction with the ordering physician or clinical director and laboratory protocols. Review the patient's history and verify the medical order.
- Follow sleep center protocols related to the sleep study. When patient arrives, verify identification, collect documents and obtain consent for the study.
- Explain the procedure and orient the patient for either in center or home sleep apnea testing.
- Provide age appropriate patient education.
- Select appropriate equipment and calibrate for testing to determine proper functioning and adjust if necessary. Apply electrodes and sensors according to accepted published standards.
- Apply and titrate positive airway pressure.
- Perform routine positive airway pressure (PAP) interface fitting and desensitization.
- Score studies in accordance with AASM standards.

## **Requirements:**

- For Polysomnographic Technologists, certification by the Board of Registered Polysomnographic Technologists or RRT-SDS credential is required. For RRTs, state licensure is required.
- Minimum 1 year of experience and PSG scoring proficiency.
- Current BLS for Healthcare Provider certification is required.
- Excellent clinical, communication, customer service, and organizational skills.
